Bidders are required to follow the electronic bid submission procedure as specified in e-GP System Operating Guideline 2073 and Usser manuals issued by PP MO which are available on e-GP system. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend on 5-06-2019 14:00 PM noon at the office of Aanbookhaireni Rural Municipality. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of specified as below, which shall be valid for 30 days beyond the validity period of the bid. The scanned copy of bid bid security should be uploaded in the e-GP system during bid submission.
