- Pre-bid meeting shall be held at **Aanbookhaireni Rural Municipality, Aanbookhaireni Tanahun** on **26-05-2019 13:00 PM noon**.
- Electronic bids must be submitted through PPMO website www.bolpatra.gov.np/egp on or before on **5-06-2019 12:00 PM noon**. Bidders are required to follow the electronic bid submission procedure as specified in e-GP System Operating Guideline 2073 and Usner manuals issued by PP MO which are available on e-GP system. Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives who choose to attend on **5-06-2019 14:00 PM noon** at the office of **Aanbookhaireni Rural Municipality**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **specified as below**, which shall be valid for 30 days beyond the validity period of the bid .The scanned copy of bid bid security should be uploaded in the e-GP system during bid submission.
- If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
